<u>Structure, Governance & Management</u> Auchterarder & District Community Trust is a Trust governed by a Trust deed.

Trustees are appointed under the terms of the trust deed.

The trustees meet every four months to consider any applications received and to make awards in accordance with the published guidelines agreed by the trustees.

The trustees also consider the appropriate location for its funds and are assisted in this matter by an Independent Financial Advisor.

The administration of the trust is carried out by Julia Reid, for which an honorarium is received.

Objectives and Activities

The trust exists for the advancement of community development.

During the course of the year 8 applications for funding were received and considered. The awards made were as follows:

All recipients of awards have been asked to provide, within a 12-month period following the receipt of their award, feedback on how their award has been used and the community benefit provided.

Financial Review

The trust received three grants in the course of the year. The first was £14,066 from Scottish Power Renewables - the seventh of 25 index-linked annual instalments - for the windfarm at Greenknowes. The second was £5,346 via Foundation Scotland for the windfarm at Burnfoot Hill. This represents the fourth annual index-linked instalment. The third for £3,200 is the first instalment, also via Foundation Scotland, for the windfarm at Burnfoot North. These latter two funds are for distribution in the Glendevon area only, and are therefore held as restricted funds.

The trust aims to award grants equivalent to its regular annual income, less costs. For the general fund in 2014 this equates to £14,066 SPR grant plus £4,131 interest received less £2,173 costs. The total amount available for distribution in 2014 was therefore £16,024 plus the balance remaining from 2013 of £31,441 making £47,465 in total. For the restricted 'Burnfoot' fund, the amount available for distribution is £21,334.

Total awards made from regular income were £9,306, as detailed above. No awards were made from the 'Burnfoot' fund and no applications were received.

This leaves up to £38,159 available for distribution from the General fund at this time, and £21,334 from the restricted 'Burnfoot' fund.

The trustees reviewed the investment strategy of the Trust during 2014 and decided to continue with the existing policy of depositing funds in interest-bearing bonds from reputable 'high-street' institutions adhering to current banking guarantees of £85,000 per institution.

Reserves

The trust aims to award grants equivalent to it's regular annual income and to treat any other donations as capital, but the trustees are not bound by this and can award all available funds at their discretion.
